ANNEX No. 4 TO DECISION NO. 7/2021 IN RELATION TO THE DEVELOPMENT OF THE CRISIS SITUATION IN THE SPREAD OF COVID-19 DISEASE CAUSED BY THE NEW CORONAVIRUS SARS-COV-2

Article 1

The text of Article 3, Paragraph 2 and 4 is deleted and replaced by the following:

- 2. Only students whose personal presence is not prohibited by a measure of the Ministry of Health of the Czech Republic and who have also undergone testing with a negative result in the last 7 calendar days or are exempted from the testing obligation may enter BUT buildings with the exception of dormitory buildings.*

Students are obliged to provide BUT with a written declaration on honour every day before entering the BUT buildings, with the exception of dormitories and canteens, that they do not have symptoms of a viral infectious disease and that they have not been ordered quarantine or isolation. In the event that the student has already suffered from the disease, he/she declares that he/she has been without symptoms of the disease for at least 3 days and that his/her isolation according to valid regulations ended before today. Declarations on honour are filled in electronically in the BUT information system (hereinafter "BUT IS"), declarations on honour are archived.

- 4. In the common areas of BUT buildings and in classrooms, employees, students and other persons are obliged to observe the maximum possible distances from other persons.*

Article 2

The text of Article 7, Paragraph 5 and 4 is deleted and replaced by the following:

- 5. Cross-border students who, for the purpose of education, regularly cross the state border with the Czech Republic from the neighbouring state and back at least once a week, shall prove this fact to the study department of the faculty/department at which they study by a declaration on honour. This provision can be used only if the student participates in permitted full-time studies according to Article 6, Paragraph 2 and is not accommodated in the Czech Republic, it cannot be used for a one-time student arrival for an exam or individual consultation in case of accommodation in the*

Czech Republic and due to travel to the place of accommodation with a prohibition on the personal presence of students while studying at university.

Article 3

The text of Article 11, Paragraph 7 is deleted and replaced by the following:

7. *Dormitory and canteen staff have the right to request from the accommodated foreign student or employee to submit a report on the result of the test for the presence of SARS-CoV-19 virus or for the presence of SARS-CoV-19 antigen according to Tables 1, 2 and 3 and undergoing COVID-19 disease according to Annex No.2.*

Article 4

1. The other provisions of this BUT internal standard remain unchanged in their original version, with the exception of the updates made to Table 1, Table 2 and Table 3.
2. This Annex shall enter into force on the date specified in its title.
