## **ANNEX No. 3 TO DECISION NO. 7/2021 IN RELATION TO THE DEVELOPMENT OF THE CRISIS SITUATION IN THE SPREAD OF COVID-19 DISEASE CAUSED BY THE NEW CORONAVIRUS SARS-COV-2**

### **Article 1**

The text of Article 3, Paragraph 2 is deleted and replaced by the following:

2. *Only students whose personal presence is not prohibited by a measure of the Ministry of Health of the Czech Republic and who have also undergone testing with a negative result in the last 7 calendar days or are exempted from the testing obligation may enter BUT buildings with the exception of dormitory buildings.*

### **Article 2**

The text of Article 6, Paragraph 2 is deleted and replaced by the following:

2. *The prohibition set out in Article 6 (1) shall not apply to:*
  - a) *the personal presence of students at examinations attended by a maximum of 10 persons,*
  - b) *the personal presence of students in practical and clinical teaching and practice during the study of all years of medical study programs,*
  - c) *participation in clinical and practical teaching and practice of students of the last years,*
  - d) *to participate in individual consultations or counselling services (only one student and one academic or other person).*

### **Article 3**

The text of Article 11, Paragraph 10 is deleted and replaced by the following:

10. *The prohibition on providing accommodation to students does not apply to students who are permitted to have a personal presence in education under Article 6 of this Decision.*

The following paragraph 12 is added to the text of Article 11:

12. *The student's personal presence in the dormitory buildings is prohibited from 26 April 2021, unless he/she has undergone an RT-PCR test for SARS-CoV-2 or a POC antigen test for SARS-CoV-2 antigen*

*in the last 7 days performed by a health service provider in the Czech Republic included in the network of sampling centres, either at the contractual provider of BUT or another sampling centre.*

#### **Article 4**

The text of Article 12 is deleted and replaced by the following:

*The operation of libraries at BUT is permitted under the conditions specified in the valid extraordinary measure of the Ministry of Health, which concerns the operation of libraries.*

#### **Article 5**

1. The other provisions of this BUT internal standard remain unchanged in their original version.
2. This Annex shall enter into force on the date specified in its title.
