ANNEX No. 1 TO DECISION NO. 15/2021 IN RELATION TO THE DEVELOPMENT OF THE CRISIS SITUATION IN THE SPREAD OF COVID-19 DISEASE CAUSED BY THE NEW CORONAVIRUS SARS-COV-2

Article 1

1. Article 5 Paragraph 3, 4, 7, 8 and 9 are replaced by the following:

3 The obligations referred to in Paragraphs 1 and 2 shall not apply, on arrival from countries with a low or medium risk of infection, to students who arrive from a neighbouring country for less than 24 hours and who have complied with the prescribed anti-epidemic measures in that country.

and do not apply to students arriving from countries with a low, medium, high and very high risk of infection who present a certificate of COVID-19 disease, where at least 11 days but not more than 180 days have passed since the first positive RT-PCR test or a written medical certificate in English containing a seal, identification data of the doctor and his/her telephone number, issued by a doctor working in the Czech Republic or in another Member State of the European Union stating that the student:

- a) has no clinical symptoms of COVID-19, has been shown to have suffered from COVID-19,*
- b) has undergone isolation to the specified extent in accordance with the valid emergency measures of the Ministry of Health of the Czech Republic or measures of another Member State of the European Union due to a positive RT-PCR test to determine the presence of SARS-CoV-2 virus, and*
- c) at least 11 days, but not more than 180 days, have passed since the first positive RT-PCR test for SARS-CoV-2.*

A sample certificate is given in Annex 2 to this Decision. The student uploads a copy of the confirmation or certificate to the COVID module in the BUT Intraportal, in which the results of testing students for the presence of SARS-CoV-2 virus or SARS-CoV-2 virus antigen are registered.

4. Furthermore, the obligations referred to in Paragraphs 1 and 2 on arrival from countries with a low, medium, high and very high risk of infection shall not apply to vaccinated students who have been issued with a national certificate¹ in the Member States of the European Union¹ 19, when since the vaccination there expired:

- a) at least 14 days after the administration of the second dose of vaccine in the case of a two - dose schedule under the SPC, or*
- b) at least 14 days after administration of a dose of vaccine in the case of a single dose schedule under the SPC*

and the student does not show any symptoms of COVID-19. The student uploads a copy of the certificate to the COVID module in the BUT Intraportal, in which the results of testing students for the presence of SARS-CoV-2 virus or SARS-CoV-2 virus antigen are registered.

7. BUT students are required to inform the Study Department of the faculty or university they study at of the trips exceeding 12 hours, or 24 hours in the case of neighbouring countries, to countries with a low, medium, high, very high and extreme risk of COVID-19. This obligation does not apply to students who do not attend classes or examinations during the period of the effect of this Decision. Students accommodated at BUT dormitories are obliged to inform Halls of Residence and Canteen at ubytovatelky@skm.vutbr.cz about trips exceeding 12 hours, or 24 hours, in the case of neighbouring countries, to countries with low, medium, high, very high and extreme risk of infection.

8. The obligations specified in paragraphs 1 to 5 of this Article shall apply mutatis mutandis to BUT employees. Employees to whom these duties apply inform their superior about their fulfillment, or, according to the decision, the management of the BUT department where they work, the relevant personnel department. Employees are obliged to upload the prescribed confirmations and / or certificates to the COVID module in the BUT Intraportal, in which the results of testing employees for the presence of SARS-CoV-2 virus or SARS-CoV-2 virus antigen are registered

9. BUT employees are obliged to inform their superior, or, according to the decision, the management of the BUT department where they work, the relevant personnel department about trips exceeding 12 hours, or 24 hours, in the case of neighbouring countries, to countries with low, medium, high, a very high and extreme risk of COVID-19. This does not apply if they travel to these countries as part of their holiday and at the same time request the approval of the holiday electronically in the Intraportal in the Absence Planning module. In such a case, they are obliged to indicate in the form the holiday place within the scope of identification of the country with a low, medium, high, very high or extreme risk of infection.

¹ A national certificate of **vaccination** is considered to be a written certificate issued in an official language of a Member State of the European Union or in English by an authorized entity operating in the Czech Republic or another Member State of the European Union, the model of which is published in the list of recognized national certificates on the Ministry of Health website of the Czech Republic at <https://koronavirus.mzcr.cz/vzory-narodnich-certifikatu/>, which contains data on the vaccinated person, the type of vaccine administered, the date of administration of the vaccine, identification of the entity who issued the certificate.

The national certificate of **vaccination** is also a vaccination certificate issued in accordance with the European Union Regulation on the EU digital certificate COVID.

A national certificate of **completed vaccination** is considered to be a written confirmation issued at least in English by an authorized entity operating in a third country to a Czech citizen or a European Union citizen with a certificate of temporary residence or permanent residence permit issued by the Czech Republic, that vaccination with a substance approved by the European Medicines Agency has been fully completed and its model is published in the list of recognized national certificates on the website of the Ministry of Health of the Czech Republic at <https://koronavirus.mzcr.cz/vzory-narodnich-certifikatu/>, the written confirmation must contain information on the person vaccinated, the type of vaccine administered, the date of administration of the vaccine, the identification of the subject who issued the confirmation and these data must be verifiable by remote access directly from the written confirmation;

2. Article 11 (c) is replaced by the following:

c) the person has been vaccinated against covid-19 and proves by the national certificate of vaccination or the national certificate of completed vaccination that the vaccination has passed:

- i) at least 14 days from the administration of the second dose of vaccine in the case of a two-dose schedule according to the Summary of Product Characteristics (SPC), or*
- ii) at least 14 days after administration of a dose of vaccine in the case of a single dose schedule under the SPC.*

3. Article 11 (d) is deleted and the current letter (e) is changed to letter (d).

Article 2

1. The other provisions of this BUT internal standard remain unchanged in their original version. However, this Annex updates Annexes No. 3-5 (overview tables).
2. This Annex shall enter into force on the date specified in its title.
