

Information on the processing of students' personal data in the framework of the BUT Student Entrepreneurship Award competition within the Go to Business! project at Brno University of Technology

Who is the controller of your personal data?

The personal data controller, i.e. Brno University of Technology with its registered office at Antonínská 548/1, 601 90 Brno, Id. No.: 00216305, Tax Id. No.: CZ00216305, data box: yb9j9by, is an university established through a law. In its activities, Brno University of Technology processes personal data in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data, and repealing Directive 95/46/EC (General Data Protection Regulation) and other legal regulations. Brno University of Technology (hereinafter "BUT") appointed RNDr. Mgr. Daniela Dvorská to be the data protection officer. Why do we process your personal data in this case?

The purpose of processing your personal data in this case is to support you in the BUT Student Entrepreneurship Award competition, within the framework of the **Go to Business!** project, which is implemented in cooperation with JIC (South Moravian Innovation Center), an interest association of legal entities that is engaged in supporting and searching for entrepreneurial innovation activities in the region. **Participation in this competition is voluntary, you can apply via MS Forms.** You can find out more about data security and privacy in MS Forms at <https://support.microsoft.com/cs-cz/office/zabezpe%C4%8Den%C3%AD-a-ochrana-osobn%C3%ADch-%C3%BAtaj%C5%AF-v-microsoft-forms-7e57f9ba-4aeb-4b1b-9e21-b75318532cd9>.

What personal data do we process about you for this purpose?

In order to support you and subsequently evaluate the benefits of the project and to demonstrate the efficient use of public funds, we need to process this personal data about you in documents in paper or electronic form or in electronic information systems:

a) Identification data

1. name and surname, titles
2. personal number (BUT ID)
3. name of the faculty you are studying at
4. the programme (field) you are studying
5. year in which you are currently studying

b) Contact details

1. e-mail address, which is your e-mail address in the information system of the BUT, through which we will communicate with you and to which you will receive information about the project and events organized within the project

Do we process your personal data in accordance with applicable law?

Yes, the legal basis for the processing of personal data by the controller is the performance of tasks of a public university in the public interest, in particular in accordance with the provisions of the Higher Education Act and the Statute of the BUT.

Will we pass on your personal data to anyone?

Yes.

The BUT Student Entrepreneurship Award within the framework of the project Go to Business!, which you want to join, is implemented within the development project of the Ministry of Education, Youth and Sports of the Czech Republic "Support of Student Entrepreneurship". The BUT is cooperating with the JIC, an association of legal entities, with the registered office at Purkyňova 649/127, Medlánky, 612 00 Brno, ID No.: 71180478 (hereinafter referred to as "JIC"). The task of this institution will be to help you with your entrepreneurial activities, for this reason it needs information about your person and your e-mail address in order to contact you. The BUT and the JIC will process personal data as joint data controllers in accordance with Article 26 of the General Data Protection Regulation. If we cooperate with other companies on the basis of a contract in the "Go to Business" project and if the cooperation with them requires the transfer of your personal data, you will be informed in accordance with the applicable legislation.

Upon request, your personal data may also be provided by law to the Ministry of Education, Youth and Sports of the Czech Republic and may also be transferred to the competent control authority, solely on the basis of its authorisation under the law.

How long will we process your personal data?

Your personal data will be processed in documents in paper or electronic form or in information systems until 31 December 2035 in connection with your participation in the BUT Student Entrepreneurship Award, within the framework of the Go to Business! project, after which the documents containing personal data will be assessed and proposed either for transfer to the BUT Archives or for destruction. Personal data in electronic form or in electronic information systems will be dealt with in a similar manner (archiving or deletion).

Rights of data subjects

A data subject has the right to request from the personal data controller (hereinafter also the "data controller") access to personal data (he/she can request information as to which personal data relating to him/her are being processed), rectification and erasure of personal data and restriction of processing. A data subject has the right to object to processing and the right to portability of personal data.

A data subject can deliver the requests to exercise the rights specified in the preceding sentence in person to the filing department of BUT at Antonínská 548/1, 601 90 Brno, or via electronic mail to vut@vutbr.cz. The aforementioned request will be assessed and dealt with in accordance with GDPR and other applicable legal regulations.

A data subject has the right to lodge a complaint with the supervisory authority, i.e. the Office for Personal Data Protection, stating that the processing of his/her personal data violates GDPR.
