

## **ANNEX NO. 1 TO DEAN'S DECISION NO. 15/2020**

### **SCHEDULE AND CONDITIONS OF PARTICIPATION IN PRESENTATION FORMS OF TEACHING IN THE FACULTY OF TEACHERS AND STUDENTS IN THE BACHELOR'S, MASTER'S OR DOCTORAL STUDY PROGRAM**

1. Based on the Resolutions of the Government of the Czech Republic of 20 November 2020 No. 1263 on the adoption of a crisis measure, the operation of higher education institutions is limited to:
  - a. participation in clinical and practical teaching and practice, students of study programs in general medicine, dentistry, pharmacy and other medical study programs and students performing pedagogical practical teaching and practice in kindergartens, primary and secondary schools or school facilities for institutional and protective education,
  - b. participation in clinical and practical teaching and practice, which takes place with external entities,
  - c. laboratory, experimental or artistic teaching in the last year of a bachelor's or master's study program in the presence of a maximum of 20 students,
  - d. study in a doctoral study program,
  - e. individual consultations and individual visits to libraries, for the purpose of receiving or submitting study literature.
  - f. first-year students in the presence of a maximum of 20 students
  
2. According to point 1c, students of bachelor's and master's study programs during the study of studio work are allowed to be present for the teaching during the working hours in the areas of the faculty building, in necessary cases in the presence of a maximum of 20 people. Where possible, online teaching is still preferred. Students of the final years follow the instructions of the teacher or the guarantor of the course.

In the case of studio teaching, for reasons of health protection and maintaining the operation of FA BUT, the presence of teachers and students in the faculty areas will be spatially distributed. The aim is to minimize the risk of transmitting a viral infection and, in the event of an infection, to reduce the number of quarantined members of the academic community. Studio teachers are assigned studio rooms, in which a maximum of 20 people will stay and, subject to other hygienic measures, as follows:

3. According to point 1d, students in doctoral study programs are allowed to be present for teaching during the working hours on the faculty areas during their studies, if necessary. Where possible, online teaching is still preferred. Students of doctoral study programs follow the instructions of teachers or subject guarantors.

4. According to point 1f, first-year students of bachelor's and master's study programs are allowed to be present for teaching during the working hours on the faculty areas, if necessary. Where possible, online teaching is still preferred. Students follow the instructions of teachers or subject guarantors.
5. According to point 1e, individual consultations are possible for students of all grades. Individual consultations and presence on the faculty building areas are allowed only in necessary justified cases. In other cases, teaching must take place online. Students follow the instructions of the teacher or the guarantor of the course.

Individual consultations are scheduled by the teacher for a specific time and room in order to avoid contact between more people. The teacher archives these schedules.

6. According to point 1e, individual visits to the FA library for the purpose of receiving or submitting study literature are also allowed, see Annex No. 2.
7. All participants of teaching must have respiratory protective equipment (nose, mouth) such as a respirator, drape, mouthpiece, scarf, shawl or other means to prevent the spread of droplets during its duration. Upon entering the room, each of the participants will perform hand disinfection.
8. Respiratory protective equipment must also be used when moving in all common areas of the faculty. In common areas, employees, students and other persons are also obliged to observe the maximum possible distances from other persons.
9. In the event that the capacity of the allocated rooms ceases to be sufficient, or it will not be possible to observe the required hygienic measures, the teacher will notify the vice-dean for studies at any time during the course.
10. Other hygiene recommendations:
  - a. When staying in a classroom, try to keep your distance from others.
  - b. Ventilate often.
  - c. Try to limit the time spent by more people in one room as much as possible and do only the most necessary activities that cannot be done remotely
