ANNOUNCEMENT OF THE SECOND ROUND OF ADMISSIONS TO THE ENTREPRENEURSHIP AND SMALL BUSINESS DEVELOPMENT BACHELOR'S PROGRAMME AND THE INTERNATIONAL BUSINESS AND MANAGEMENT FOLLOW-UP MASTER'S PROGRAMME FOR THE ACADEMIC YEAR 2021/2022

Article 1

Subject matter of amendment

Pursuant to Act no. 111/1998 Coll. concerning universities (the Act) and to the Rules of Admissions to Bachelor's and Follow-up Master's programmes for the academic year 2021/2022 (the Rules) as well as Amendment no. 1 to the Rules, I announce the second round of admissions to the **Entrepreneurship and Small Business Development** bachelor's programme and the **International Business and Management** follow-up master's programme.

Article 2

Admissions dates

1. The period for submitting applications to study pursuant to Article 13 of the Rules and pursuant to Article 18 Paragraph 2 of the Rules shall be from **01. 06. 2021 to 02. 08. 2021**.

2. The entrance examination for the Entrepreneurship and Small Business Development shall take place on **26. 08. 2021** pursuant to Article 3 Paragraph 3 of the Rules.
3. The documents needed for the admissions to the International Business and Management follow-up master's programme shall be submitted by **02. 08. 2021** pursuant to Article 10 Paragraph 2 of the Rules.
4. The materials important for the decision on admission may be inspected at the Study Department of the BUT Faculty of Business and Management at Kolejní 2906/4, Brno on 01. 09. 2021 from 9:00 to 11:00 pursuant to Article 18 Paragraph 2 of the Rules.

Article 3

Final provisions

1. The remaining requisites and conditions of admissions are governed by the Rules and Amendment no. 1 to the Rules as published in the public part of the BUT Faculty of Business and Management site.
